

## AFFIDAVIT




- That this school, "TATYASAHEB KORE MILITARY ACADEMY, VINAYNAGAR" PO: Nave Pargaon, Tal-Hatkanangale, Dist-Kolhapur is being run as a community service and not as a business and that commercialization doesn't take place in this school in any shape whatsoever.
